- Article 1 The National Taiwan University Center for General Education Rules Governing Procedures for the Program Affairs Committee of the Bachelor Program of International Sports Affairs ("the Rules") are formulated in accordance with Article 44 of the National Taiwan University Organizational Charter.
- Article 2 The Program Affairs Committee ("the Committee") of the Bachelor Program of International Sports Affairs ("the Program") consists of ex officio members and elected committee members as follows:
 - 1. Ex officio members shall be served by the director of the Program and all the full-time faculty members.
 - 2. Elected committee members shall be served by:
 - 1) Three members elected among jointly appointed faculty members;
 - 2) One expert in their respective field, recommended by the director of the Program and appointed by the director of the Center for General Education.
 - 3) One student representative of the Program

The director of the program shall serve as convener and chair of the Committee.

Elected committee members shall serve a one-year term but may serve consecutive terms if re-elected.

- Article 3 The Committee shall convene at least twice per semester, and interim meetings may be called as necessary by the convenor or with the countersignature of at least one-third of the committee members. In the event that the director of the Program is unable to attend, they may appoint a proxy chair.
- Article 4 The Committee may only convene with more than half of its members in

attendance, and a resolution may only be made with more than half of the attending members in concurrence.

- Article 5 The Committee is the highest decision-making body of the Program and is responsible for revising all Program regulations and determining important issues related to the Program's teaching, research, student recruitment, academic exchanges, student affairs, budgets, and Program development.
- Article 6 The Committee may establish various committees in accordance with University regulations and the Program's specific needs and delegate each committee to handle routine Program matters. The Chair of each committee shall report resolutions of each committee to the Committee for reference, except for important matters concerning the rights and obligations of faculty, staff, and students, which shall be reported to the Committee for resolution.
- Article 7 The Rules shall be passed by the Program Affairs Committee, the Center for General Education Affairs Meeting and then implemented on the date of promulgation.
