NATIONAL TAIWAN UNIVERSITY Center for General Education Regulations for the Establishment of the Bachelor Program of International Sports Affairs New Faculty Member Selection Committee

- Article 1 The Bachelor Program of International Sports Affairs ("the Program") under the Center for General Education ("the Center"), National Taiwan University (NTU or "the University") formulates the *Regulations for the Establishment* of the Bachelor Program of International Sports Affairs New Faculty Member Selection Committee ("the Regulations") in accordance with Articles 3 and 7 of the University's Guidelines for Colleges/Centers Appointing New Full-Time Faculty Members and Article 7 of the Center's Guidelines for Appointing New Full-Time Faculty Members.
- Article 2 The Program's New Faculty Member Selection Committee ("the Committee") shall handle matters pertaining to the selection of new faculty members in accordance with possible vacancies in the Program, sources of faculty members, proposed hiring time, and sought areas of expertise of the faculty members to be hired.
- Article 3 The Committee shall consist of at least five members, who shall be faculty members with the rank of associate professor or above, elected by the Program's full-time faculty members from among themselves and designated by the Director of the Center. Among the five members, two shall be faculty exempt from evaluation outside of the Center's subordinate entities, and shall be designated by the Director of the Center. However, when the number of faculty members with the rank of associate professor or above in the Program is insufficient to fill the seats, the number of Committee members designated by the Director of the Center shall not be subject to the preceding provision. The Director of the Program shall serve as ex officio member and convener of the Committee.
- Article 4 The Committee shall handle matters pertaining to the selection of new faculty members. Upon completion of the selection process, the Committee shall recommend the candidate(s) to the Faculty Evaluation Committee of the Program. If a decision of non-recommendation is made for any candidate, a document of justification shall be submitted to the Center for reference.
- Article 5 In principle, the Committee shall send the recruitment announcement to the Center for approval no later than half a year prior to the date of the initial employment of the proposed new full-time faculty member. After approval,

the recruitment announcement shall be published publicly via established domestic/foreign newspapers, magazines, or websites deemed appropriate.

The recruitment announcement shall be published publicly for at least two months. However, the preceding provision may be exempt under special circumstances as determined by the Committee and approved by the Director of the Center.

The selection process shall begin only when there are three or more applicants for each vacancy. However, under special circumstances, if the number of candidates is under three, the selection process shall only be initiated after it is approved by the Director of the Center, the Vice President for Academic Affairs, and the Chair of the University Faculty Evaluation Committee.

Article 6 Applicants whose highest degree is awarded by the University and who have not engaged in teaching or research-related services in institutions other than the University for more than two years after obtaining their highest degree from the University shall be excluded from the list of candidates, except for those with special expertise or outstanding performance as determined by the Committee.

The years of service in the applicant's previous job shall, in principle, be calculated based on full-time employments; in case of part-time employments, only half of the years of service shall be calculated into the applicant's seniority.

Article 7 The Regulations shall be passed by the Program Affairs Committee and the Center for General Education Affairs Meeting, and then implemented on the date of promulgation.
